ABOUT THE ASCP CONCRETE PAVEMENTS CONFERENCE

In 2011, ASCP held its first Concrete Pavements Conference in Sydney. At that time, we had invited the International Society for Concrete Pavements (ISCP) to hold their August Board meeting in Sydney, and for some ten of their Directors to present technical papers at our Conference. This Conference was regarded as a great success, and provided our Australian practitioners with valuable information from overseas. It was decided to make this ASCP Conference a biennial event.

The aim of the Conference is to provide our industry with current and detailed information about concrete pavement design, construction, materials and equipment from within Australia and from overseas. The Conference is a very different format from our various Forums held throughout the year. It provides more depth of information presented on specific topics, and creates a wonderful opportunity for industry members to discuss such matters with the presenters and their colleagues.

The Conference is a full day technical event, followed by a social, networking function in the evening.

THE 2013 CONCRETE PAVEMENTS CONFERENCE

The ASCP National Executive has decided to again seek presentations from overseas experts in concrete pavements. Based on the value of the 2011 Conference, this event provides a unique opportunity to access information which is otherwise not readily obtained.

The Executive hopes to attract overseas presenters for at least half of the Conference program, as well as to attract Australian practitioners to present on current topics.

THE CONFERENCE VENUE

The Australian National Maritime Museum at Darling Harbour provides an excellent conference room, spacious pre-conference area where morning and afternoon teas and lunch will be served, and an impressive dining room which overlooks Darling Harbour. The Museum itself holds an extensive collection of maritime historic artefacts.

TOPICS OF INTEREST

The intent of this Conference is to present information which adds to the current body of knowledge and experience. Presentations which provide new and forward looking information are sought, and are expected to address the fields of design, materials, construction, equipment, sustainability, research and education.
