ABOUT THIS FORUM

The June 2024 ASCP Pavement Technical Forum will feature speakers across the full spectrum of the concrete paving industry, with topics as widely varied.

The morning sessions will see **Peter Carson** (Carson Group) delivers a Concrete Pavements Overview of Hexham Straight, followed by Honorary Member **Geoff Ayton**, who examines the subgrade drag model – implications for design and construction.
